## LUNG CANCER SCREENING HAVE BEEN ADDED TO OUR PROGRAM

# <u>Screening for Lung Cancer</u> – available for Members only – No spouses or dependents unless they are active or retired PFD members covered by the Health Plan.

Lung cancer is the number one cause of cancer-related death in the U.S. Fortunately when lung cancer is detected early, there are more innovative lung cancer treatments available, offering the best chance for a successful outcome.

The Temple Healthy Chest Initiative (THCI) offers lung cancer screening with low-dose CT (LDCT) scan, a quick and effective way to catch lung cancer in its early stages – even before you have symptoms. If you're at high risk for lung cancer, getting an annual lung cancer screening could be life-saving.

These scans can also reveal other conditions in the chest like lung disease, such as COPD, heart issues, or even osteoporosis. Through the Temple Healthy Chest Initiative patients will be made aware of any findings and be connected to specialists as needed.

## **SLEEP APNEA / HEART SCAN**

### <u>Sleep Apnea</u> – Available for members and dependents . For an appointment or more information call 215-728-2148.

Temple's sleep disorder's center provides rapid diagnosis and treatment for sleep apnea and other sleep conditions such as narcolepsy, insomnia and restless leg syndrome. The program is equipped with a team of sleep specialists with extensive experience and knowledge to provide patients with high-quality care through all stages of evaluation and treatment.

From <u>sleep studies</u> and diagnosis, to monitoring and follow-up care, we're a large center with several attending physicians who are board-certified and fellowship-trained in sleep medicine. Temple offers in-lab, in-home or contactless sleep studies for your convenience.

Treatment for sleep apnea typically includes continuous positive airway pressure (C-PAP) as well as positional therapy, oral appliances and Inspire upper airway stimulation. Additionally, we work with Temple's Ear, Nose and Throat specialists to offer surgical procedures when necessary. We can typically see patients, evaluate them, and begin treatment much more quickly than other sleep centers — sometimes within a few days.

### <u>Heart Scan</u>

All members and dependent spouses eligible for benefits under the IAFF Local 22 Health Plan are eligible for the scan. If you have a significant family history of a coronary event we recommend this scan. Please contact Temple at (215) 707-8800 for appointments.

As a result of our continued commitment to the Health and Wellness of our members, Local 22 Health Plan is hosting an Ultrasound Screening Mondays to Fridays starting Monday, April 18<sup>th</sup> through Friday, April 29<sup>th</sup>, 2022. This event will take place at Local 22, 415 N.5<sup>th</sup> Street, Philadelphia, PA, 19123-4095.

## Why should you participate in the Heart-Vascular and Cancer Ultrasound Screening?

**First**, early detection of any cardiovascular issues is crucial for preventing a serious health crisis. Unfortunately, doctors are usually unable to prescribe diagnostic tests without symptoms. A Heart and Vascular *screen tests for plaque build-up on the artery walls, blockages or restrictions in blood flow and indicates signs of potential strokes, heart attacks or aneurysms.* 

Second, our health screen partner, National Diagnostic Services, is the <u>only mobile screening company in</u> <u>the nation that is a certified cardiovascular lab.</u> They are also the only provider from whom you will receive a comprehensive evaluation of the major abdominal organs to detect serious illnesses such as cancers, tumors and blood clots.

All tests are ultrasound based and therefore painless, and non-invasive. Tests include an Echocardiogram, Carotid, Abdominal Aorta, Thyroid, Liver, Spleen, Bladder, Kidney, and Testicular. This screen also includes an Exterior Pelvic scan for females. The examination will take approximately 30 min to complete.

Pre-registration is required. To schedule your appointment:

- 3. Complete the requested fields
- 4. Click "Submit"
- 5. Under "Choose your location" select: "IAFF Local 22"
- 6. Under "Choose Your Type of Appointment" select: "Ultrasound Screening"
- 7. Click "Search"
- 8. Select your desired appointment date/time (note: room number does not matter! Pick either 1 or 2)
- 9. Click "Book"
- 10. A blue dialog will appear, Click "Book Appointment"
- 11. You will get a welcome email and appointment confirmation email with exam instructions

### **MEDICARE PART B REIMBURSEMENT NEWS**

Local 22 Health Plan members and their spouse who are eligible for Medicare Part B are entitled for reimbursement. Local 22's E Board won this benefit for our members in a past Arbitration award. This is a city funded benefit.

In the first Quarter of 2022 most Medicare Part B recipients had changes made to their premiums. It is the members responsibility to notify the Health Plan of these changes. Most changes are increases to your premium. Some changes may be decreases in the premium. Members with increases will not see the increase in their reimbursement unless the Health Plan is notified. Members with decreases in premium risk the chance of losing their benefit if you do not report the proper adjustment.

### **SPOUSAL VERIFICATION AUDIT**

LOCAL 22Health Plan has hired PDA to perform a Spousal Audit. Letters went out in February to all Health Plan members carried as Married in the Health Plan database. The reason for the audit is to ensure that the Health Plan is covering only eligible spouses. Members who get divorced and do not not tify the Health Plan within 30 days are responsible for any medical bills we receive for their ex-spouse. The Audit will help us protect members from receiving the large bills from their ex spouse bills.



#### **FY 22 WELLNESS INCENTIVE**
